#### 7:15 Notice of Intent: 54 Martin St., Jones Field

*The Town of Acton's Department of Natural Resources for a project at 54 Martin Street, (town atlas plate H2A, parcel 52). The Project is to remove the existing playground and associated structures and replace with a new accessible playground, additional parking and sidewalk. Work will occur within 100 feet of wetlands.*

Tom Tidman presented plans for the project showing the temporary disturbance within both the inner and outer riparian zones. The construction sequence was discussed, starting with the construction of the proposed 25 car parking lot along Stow St. The Commissioners discussed DEP's comments requiring a Stormwater Report be filed. Mr. Tidman noted that the Stormwater Report would be written by Town Engineer Paul Campbell.

The Chairman continued the NOI hearing to August 21 at 7:20 PM.

*Abbreviated Notice of Resource Area Delineation located at 66 Maple St, (town atlas plate H2, parcel A, lots 23 & 41-6) filed by Michael Diplatzi, Property Acquisition Group.*

Mr. Maitland stated that a client of his in Concord is currently using Stamski & McNary for a project. He is, however, comfortable participating as a commissioner for this hearing.

Paul Kirchner, from Stamski & McNary, presented for the applicant, Michael Diplatzi. As a result of the site visit of August 6, the Commission was concerned that the flags were not readable and questioned when Dave Crossman originally flagged the site. Paul agreed to move wetland flags 3 and 4 approximately 4 feet north. The new locations are shown on a revised plan dated Aug. 6, 2019.

Ms. Green moved to approve the wetlands delineation as presented; noting that flag 4 is moved 4 feet to the north. Mr. Colman seconded the motion and it passed unanimously.
