OLD BUSINESS:

- Tory Beyer & Anita Dodson from the Historical Commission are in attendance to answer any questions or concerns about putting the cemeteries on the National Historical Register. Ms. Beyer stated that by getting the cemeteries on the Register we could then have CPC money and Federal grant money available to make improvements and restorations to the cemeteries. Questions about road repairs, tree replacements, hedgerows and shrub replacements, stonewall re-pointing, as well as gravestone maintenance and repair were proposed. Mrs. Beyer stated she would look into all of those projects to see if they would qualify. Otherwise the Cemetery Commissioners feel that it would in fact be in the best interest of the cemeteries to go ahead with the registration.

- Commissioner Klauer would like to have a letter of thanks sent out to Jimmy O'Neil for his clean-up efforts at the Robbins house site. An excellent job! Motion – 2nd – pass. Mr. Klauer will draft the letter and send it.
- William Kramer, owner of Lot 2 & 3 Section 8 Woodlawn, has requested that he be allowed to put three monuments on his 2 lots as indicated on the attachment. Shawn feels that we can accommodate this request as long as Mr. Kramer sticks to Shawn's proposed resolution. Motion – 2nd – passed.
- Selectmen's oversight meeting is November 2, 2009 at 8:15pm. Mr. Klauer wants to create an outline of topics for discussion to determine an amount of time required to discuss the Commissioners concerns.



Hi William,

I went out and looked at your lot late last week and have attached a pdf of my sketch so that you can picture what I am talking about. If what I have sketched is not what you had in mind please let me know. I think that there is enough space for your lot to have three monuments. I have marked the proposed monument locations as A, B & C on my sketch. The monuments would have to be no larger than 3' 6" x 1' 2". The monuments at locations B & C do provide a little flexibility in that if you wanted one to be larger than 3' 6" we could do that as long as there is a corresponding decrease in the size of the other. If you find this arrangement to be acceptable please write a letter to the cemetery commission detailing your request. Our next meeting is Wednesday Sept 10th. If you were to send me an email rather than a written letter we can probably get it on the agenda for that meeting.
