

EAGLE SCOUT PROJECT - Paul Mederios

Paul Mederios presented his report on the replacement of the boardwalk at the Wills Hole conservation land for his Eagle Scout Project.

Mr. Mederios reported that the project took 117 man hours to complete the replacement of 160 feet of raised boardwalk, and a sign posting the "Wills Hole Conservation Land" dedicated by Paul Mederios

8:09 **CERTIFICATE OF COMPLIANCE** - Lot 13 & 14 Candida Lane 85-54

The Administrator reported that he has received a request by the developer to release Lots 13 & 14 Candida Lane from the Order of Conditions, DEQE #85-54. The Administrator has inspected the site, and finds it to be complete.

Mr. Dow moved to issue a Certificate of Compliance for Lots 13 & 14 Candida Lane. Mr. Young seconded the motion. The motion passed unanimously.

The Administrator reported that he has received a filing for a Notice of Intent for the above noted address for the construction of a warehouse and support office within the 100' buffer zone.

VILLAGE AUTO - 61 POWDER MILL ROAD 85-156

Mr. Young reported that he suspects 61 Powder Mill Road, DEQE #85-156 to be in violation of their Order of Conditions by not having any erosion control devices in place.

Mr. Tidman stated that he would investigate the matter, and report back to the Commission.

The Administrator reported that the hearing was cancelled by the applicant as they could not get a person to present the filing, they have rescheduled for February 1, 1989.
