**DISCUSSION OF POTENTIAL MERGING OF THE ACTON NURSING
SERVICE WITH PARMENTER HEALTH CARE**

Doug Halley spoke about the different strategies and is there a way to share services. Heather spoke with Parameter and they discovered there were different things to share and they could obtain some financial benefits.

They were discussing changes at Parameter which services 22 communities
We started initial investigation. We will need to share documents and information with them as we progress with the process.

Doug said we should go through the details to see what happens, and it may take us 5-6 months to come back to the board to say this is what we have accomplished. He feels we need to include them in our metrics and look into whether we need a RFP and do we need to offer to home cares that are not compatible with Acton.

Heather spoke about ACO's and there are a lot of big services out there.

Ms. Harting-Barrat asked, do we move ahead, and we need to continue to fund service to provide same level of service to the residents of town. If the answer is no, then we move on and maybe consolidate with another agency but we still need to spend the time to investigate.

Mr. Gowing asked how they envision this, is it the purchase of assets. They are interested in our name, and Parameter likes that.

Ms. Adachi discussed what is best for the residents. Part of issue is finance. She said she would be supporting this and move forward and have them come back to the Board.

They have been exchanging conversations and are looking in to it with Parameter; they are not yet at the point of RFP.

Steve Ledoux noted we would need to have two votes on the Town Meeting Warrant to dissolve the Nursing Service and Enterprise funds.

Mr. Sonner asked about the financial arrangements. Doug felt if we are going to reach an agreement that the subsidy should be lower.

Mr. Gowing asked about having a Public Health Nurse to cover our obligations.

Ms. Harting-Barrat said the number of people who don't have insurance and need the resource to pay for those services. If Parameter could help us maintain that it would be wonderful, and we need to investigate this further for the citizen's of Acton.


Heather noted they have hospice care and that will be available to us.


