7:32am. Karen O'Neill, Chair called the meeting to order and conducted roll call.

**I. Regular Business**

**1. Review meeting minutes of Aug. 2. 2024**

- a. 7:33am. Terry Maitland moved to approve the August 2<sup>nd</sup> minutes and Matt Mostoller seconded. The Chair called for a roll call vote, all voted yes and Bettina Abe abstained.

- The Chair gave a reminder to the Committee that members are still needed.

**2. Status of property Conservation Restriction (any changes)**

- a. 7:34am. Anderson CR. The CR is close to being done. The state requests a copy of the plan. Sudbury Valley of Trustees (STV) will reach out to the state for an update.
- Genevieve Lane posted a sign on the street stating "Private road for residents and guest only no trespassing". The Conservation Restriction (CR) in the back of Genevieve Lane has a provision for public access, and there is kiosk at the end of the street. The sign violates the CR. Ms. Barksdale or Mr. Bergemann will reach out to the residents and developer to request that they remove the sign or add language to the sign permitting pedestrian access.
- Annual CR monitoring is planned for October 16<sup>th</sup> (Gabel and Grassy Pond West), and October 23<sup>rd</sup> (Central Street and Wright Hill).
