**Description of Proposed work:**

Re-roof using "Certainteed Landmark Series" asphalt shingles.

\* Excluded under Chapter P, Sect. 9.3: "...repair or replacement of any exterior architectural feature... which does not involve a change in design, material, or the outward appearance thereof,"...

**Conditions, requirements, recommendations:**

1. Replacement shingles shall be high-definition style. Ultra-high definition style shingles are not permitted.
2. Drip edge color must match wood trim color.
3. Ridge vent (if used) must run from gable end to gable end.
4. Chimney flashing (if used) must be lead or lead-coated copper. Mill finish aluminum is not permitted.
5. Any vent pipe flashing visible from School Street must be black neoprene, copper or lead-coated copper. Mill finish aluminum is not permitted.
6. Vent pipes should be metal; if PVC then PVC should be painted a dark color.

The applicant may proceed with the proposed work provided all other approvals have been obtained, including a Building Permit or Sign License where required. This Certificate is valid for work commenced within one year of the date of issuance. An extension or renewal of the Certificate may be granted at the discretion of the commission. If a property changes ownership during the time the Certificate is in force, a new owner who wishes to continue the authorized work must apply to have a new Certificate issued in his or her own name.



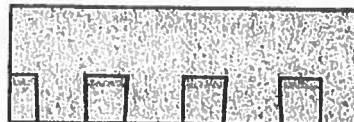

### PRODUCT INFORMATION

Landmark® shingles reflect the same high manufacturing standards and superior warranty protection as the rest of CertainTeed's line of roofing products. Landmark (and Algae Resistant-AR) shingles are built with the industry's toughest fiber glass mat base, and their strict dimensional tolerance assures consistency. Complex granule color blends and subtle shadow lines produce a distinctive color selection. Landmark is produced with the unique NailTrak® nailing feature.



Landmark algae-resistant (AR) shingles are algae-resistant and help protect against dark or black discoloration, sometimes called staining or streaking, caused by blue-green algae. AR shingles are not available in all regions.

**Colors:** Please refer to the product brochure or CertainTeed website for the colors available in your region.

**Limitations:** Use on roofs with slopes greater than 2" per foot. Low-slope applications (2:12 to < 4:12) require additional underlayment. In areas where icing along eaves can cause the back-up of water, apply CertainTeed WinterGuard® Waterproofing Shingle Underlayment, or its equivalent, according to application instructions provided with the product and on the shingle package.

**Product Composition:** Landmark shingles are composed of a fiber glass mat base. Ceramic-coated mineral granules are tightly embedded in carefully refined, water-resistant asphalt. Two pieces of the shingle are firmly laminated together in a special, tough asphaltic cement. All Landmark shingles have self-sealing adhesive strips.

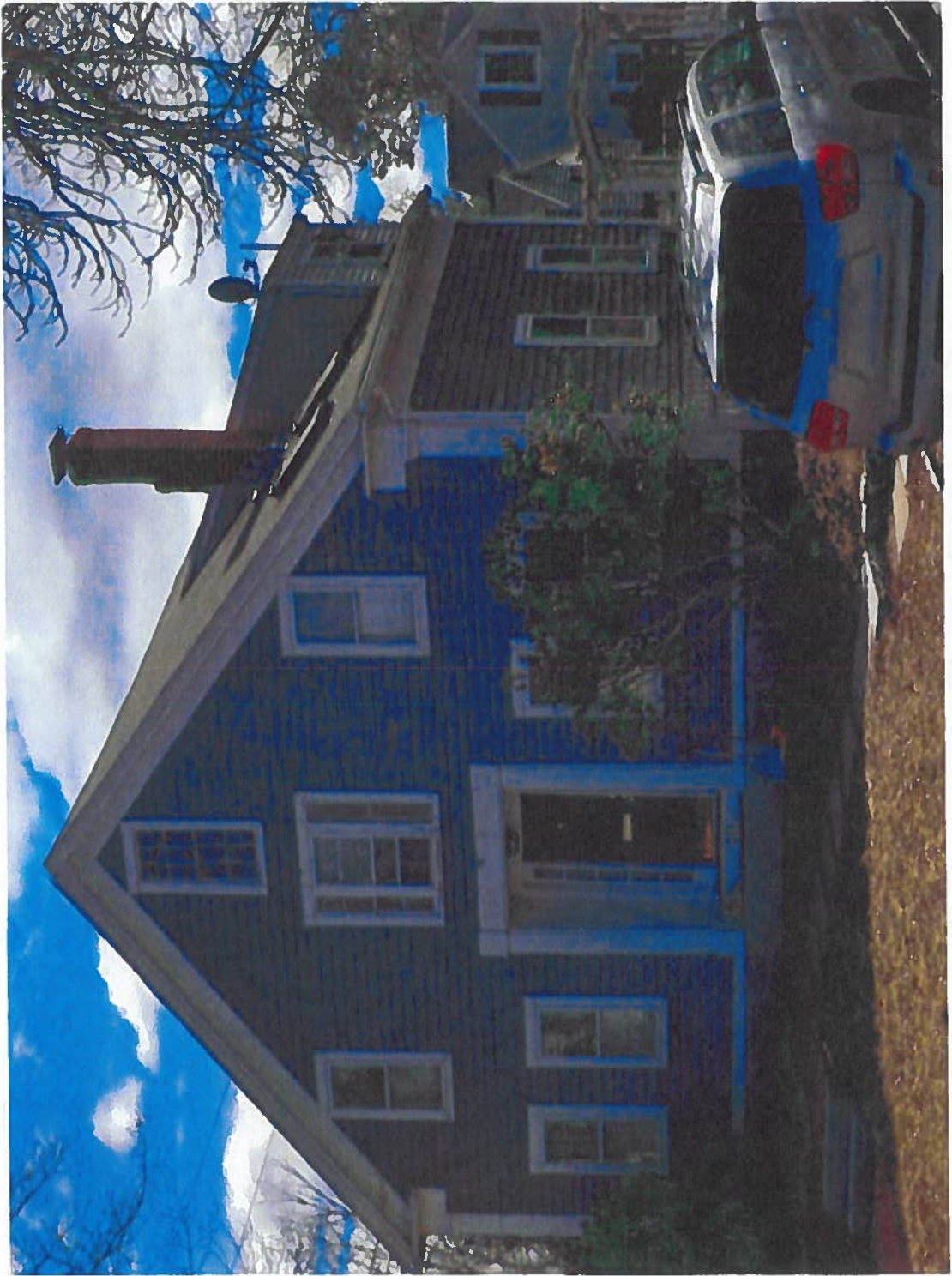

### Scope of work:

All roof sections of home.

- We will supply a clean dumpster with lumber under the wheels to prevent any damage to driveway.
- We hang tarps to protect your property and strip up to (1) layer(s) of roofing\*
- Inspect roof sheathing and re-nail or replace as needed (\*\*Sheathing replacement cost noted below).
- Install aluminum pipe flanges & inspect & replace aluminum step/wall flashing as needed or required
- Install **CertainTeed WinterGuard** granular ice & water shield 6 ft. up from eaves, in valleys & under all step flashing areas.
- Install **CertainTeed RoofRunner** or Rhino synthetic paper in all other areas not covered by ice & water shield.
- Install 6" aluminum drip-edge along entire perimeter of roof. Vented drip edge stays in place unless otherwise discussed.
- Install **CertainTeed SwiftStart** starter shingles around entire perimeter of roof (ensures proper edge adherence).
- Install #1 rated **CertainTeed Landmark** architectural shingles (6 nails per shingle for 130 mph wind warranty).
- Cut 2" opening at ridge location (when needed) and install **CertainTeed ShingleVent** baffled ridge vent.
- Install **CertainTeed ShadowRidge** cap shingles on all ridge and hip locations.
- Inspect property upon completion. Clean up debris & perform magnetic sweep for nails.
- THE DUMPSTER SUPPLIED IS FOR THE ROOF PROJECT ONLY. ANY HOUSEHOLD ITEMS FOUND IN DUMPSTER WILL INCUR AN ADDITIONAL \$500.00 FEE
- All unused material is the property of Apex Roofing & Restoration LLC & will be picked up following the completion of the project.
- \*\*\*Dust & debris can enter your attic and precautions should be taken by the homeowner to protect their items and although we take all necessary safety measures we do not cover any consequential damages to home or landscaping due to the roof project.

Any additional layers of shingles discovered beyond our quoted amount will be calculated @ \$40 cents per sq. ft.

Sheathing replacement: 1/2" plywood @ \$2.95 Per Square Foot 3 1x8" boards @2 per lineal foot

If required we'll replace lead flashing on brick chimney(s) for an additional charge of \$550.00 per chimney

Remove flashing from skylight(s). Install new ice & water shield & re-install flashing for \$100.00 each unit not being replaced.
