AGENDA TOPICS

Meeting called to order at: 7:00 PM

TOPIC: CITIZENS CONCERN

DISCUSSION	Vandana Sharma who lives in Robbins Mill Subdivision, wants better equipment (like swings) at the Robbins Mill Recreation area. Playground currently has a lot of climbing equipment. Ms. Fochtman remarked that if we were to install a two bay swing set, it would take up most of the space and we'd have to remove most of the equipment. The space is 50' x 55'. Vandana Sharma interviewed her 9 year old daughter and video recorded it and brought it to the meeting. The child spoke about wanting swings. They want something more challenging. The Sharmas will poll the neighbors to get consensus on what they collectively would like to see in the playground. Ms. Fochtman suggested some funding sources: CPA, grants, etc...

DISCUSSION	Ms. Fochtman updated the Commission about the plans for the trail. Recreation Commission is in favor of combining the rail trail with the NARA trail, rather than taking down the line of trees. Chairman McKeever-Matz moved that the Commission approve the redesign of the shared BFRT with as little disruption to the existing trees and landscape as possible in collaboration with the Acton's Natural Resources Department.
