Update - Main Street Master Plan

Ms. Cousins stated the Main Street Master Plan Committee (MSMPC) has had only one meeting. No news at this time. Will further discuss the smart flower solar panel system at the property of 348-364 Main Street and the different options and ideas for possible solar for a residential or commercial project.

Discussion Green Communities Annual Report 2016

Ms. Crosby reviewed the goal of a 20% reduction of the Town's of energy use over a five year span and working on the upcoming Green Communities Annual Report with Ms. Ristine due on December 2, 2016. Ms. Crosby explained and explored the spreadsheet s in which information and data is compiled in and the Regional School District's energy consumption.

Discussion - Solar Canopy Proposal - Massachusetts Bay Transportation Authority (MBTA) (010)

Mr. Berry stated the Board of Selectmen (BOS) is placing this project on hold until the spring. The Board briefly discussed the next steps for tracking the solar on buildings, locations and any HDC issues. The Board discussed Mr. Loria's memo that was submitted to the BOS; Mr. Loria was not present to discuss memo.


