## BUILDING & SHEET METAL

**\$14.75 per \$1000 of estimated construction value, plus \$5.00 per page/plans. A minimum fee may apply. (1) For new construction the estimated cost shall be based on the average sq. ft. cost as published in the Latest edition of the ICC building valuation data report.**

Roofing, Windows, Siding, Mechanical, Tents,  
Wood Stove, Demolition, Sheet Metal **\$55.00** (Minimum Fee)

All Other Building Permits **\$75.00** (Minimum Fee)

Construction Started Without a Permit **DOUBLE FEE**

## WIRING

---

**2.5% of the value of electrical work (including labor and materials). A minimum fee may apply.**

**The value of electrical work will be based on a signed contract between the person or corporation doing the work and the person or corporation paying for the work**

New Dwellings **\$200** (Minimum Fee)

Residential Alterations **\$60** for the first inspection  
add **\$40** for each additional inspection

Residential Swimming Pools **\$150** (Minimum Fee)

Residential Solar Installations **\$120** (Flat Rate)

Commercial Work **\$80** (Minimum Fee)

## PLUMBING & GAS

---

New Home **\$240** up to 11 fixtures; add **\$5** for each additional fixture

Residential Alterations **\$60** for the first inspection **\$40** for each additional  
inspection up to 5 fixtures then **\$5** for each additional fixture

Gas Hot Water Heaters **\$100** (requires both a Plumbing and Gas Permit)

Commercial **\$100** for the first inspection, **\$80** for each additional  
inspection up to 5 fixtures then **\$5** for each additional fixture

## TRENCH

Trench Work Started Without a Permit **\$240**

In the event of an unattended unprotected trench the property owner and excavator of the trench will be fined a minimum of \$800 per day or fraction thereof plus (1) the cost to have a police detail provided by the Town of Acton to attend to the unsecured trench and (2) time, materials and equipment to secure the trench as the Town sees fit

In the event that the Town of Acton provides rescue services as the result of a trench, which does not meet the standards set forth by the aforementioned regulations, the property owner and excavator will pay all associated rescue costs (time, material & equipment).
